Please note that you may be asked to remove some items from your booth. Submission of this application constitutes your agreement to comply with any such notice from the Office of the Fair.

Rent is for the use of the land only. All concession spaces are outdoors. There are a limited number of available electrical outlets on a first come first served with the Renter to supply own extension cord (maximum one (1) per concession). With a paid-in-full Concession Rental Agreement, two (2) Concession Passes will be provided for all days of the Fair.

PLEASE NOTE: It is required that all vendors show proof of current liability insurance of a minimum of \$5,000,000.00. Duo is recommended as an affordable provider for event insurance. A copy must be submitted to the Fair Office prior to set up. No alcohol or drugs allowed on the grounds.
